Note 2: STRS/PERS members that established membership prior to January 1, 2013 are considered "Classic" members. STRS/PERS members that established membership on/after January 1, 2013 are considered "PEPRA" members.

Note 3: STRS has adopted new creditable compensation regulations that affect "Classic" STRS members. The regulations are effective for compensation earned for service performed on or after January 1, 2015. Separate allowance payments for cash in lieu, fringe benefits, and business expenses will no longer considered creditable compensation.

Note 4: Cash in lieu, fringe benfits, and business expenses may be considered creditable compensation if properly restructured into base salary. Districts considering this option should consult with legal counsel to coordinate a restructure prior to January 1, 2016.
